



Fellowship of Christian Outdoors Activity Participation Agreement

Please read carefully before signing. This is a participation agreement between participants and the ministry of FCA and FCA Outdoors, its Coaches, Volunteers and Staff.

In consideration for my being permitted to participate in the activities of outdoors / sportsmen related events I agree to the following;

I acknowledge that hunting, all outdoor sports and activities surrounding these events that may occur have inherent risks, hazards, and dangers for anyone, which cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession
2. The risk of injury from ammunition and shot from other guns.
3. The risk of accidental misuse of equipment that may cause injury
4. The risk of injury from archery equipment, bows or arrows.
5. The risk of not following safety recommendations resulting in injury.
6. Exposure to inclement weather conditions and wilderness settings that may include dangerous wildlife.
7. The risk of injury from riding in a Motor Vehicle, Boat, Raft or ATV.

Voluntarily participating in this event, I understand the risks, hazards and dangers as described above and have had the opportunity to discuss them with (FCA or FCA Outdoors Event Leader)

_____. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely and have revealed any health or medical issues that could become an issue. I understand that I have responsibilities to follow guidelines presented. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES OF THE FELLOWSHIP OF CHRISTIAN ATHLETES AND FCA OUTDOORS WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

For and in consideration of being allowed to participate, I for myself, my heirs, successors, executors, and subrogees, hereby KNOWINGLY AND INTENTIONALLY RELEASE, INDEMNIFY AND HOLD HARMLESS FELLOWSHIP OF CHRISTIAN ATHLETES AND FCA OUTDOORS, their directors, officers, agents, employee, and volunteers from and against

any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees) which are related to or arise out of, or are in any way connected with my participation in this activity whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from my own non-compliance with the guidelines as presented by THE FELLOWSHIP OF CHRISTIAN ATHELETES AND FCA OUTDOORS, their representatives, directors, officers, agents, employee, and volunteers or from some other cause. I, for myself, my heirs, my successors, executors, and subrogee, further agree not to seek lawful demands of the FELLOWSHIP OF CHRISTIAN ATHELETES AND FCA OUTDOORS, their directors, officers, agents, employee, and volunteers as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of THE FELLOWSHIP OF CHRISTIAN ATHELETES AND FCA OUTDOORS, their directors, officers, agents, employee, and volunteers.
